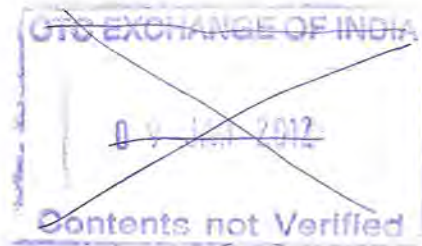


Review Report for the period from 1st January 2011 to 31st March 2011
